### Letter from EPPS Dean Jennifer S. Holmes

The spring, we have a number of exciting initiatives in the School of Economic, Political and Policy Sciences.

First of all, I am happy to announce that we are about to launch the North Texas Quality of Life Initiative. This project will identify areas of improvement and pride in regional quality of life, highlight areas of contradiction where there is a mismatch of perception and objective indicators,

and provide multiple opportunities for our students to work on a high profile, policysalient project. The goal is to provide high-quality data to inform interested partners and community leaders of people's demand for, supply of and consumption of public service delivery, and the consequences of that delivery. The core of the initiative is the William C. Short Survey. William C. Short, executive chairman and CEO of A.E. Perkins Holdings Group, previously served on the EPPS advisory council. The annual survey will be a cornerstone of the larger effort to bring decision-makers the actionable information they need to shape the most dynamic region in the country. We will launch the inaugural survey this May around local elections and will reveal the results (with contextual data) this summer.

Second, we have been busy building relationships to expand our public service commitment in EPPS. The school is the sponsor of Army ROTC, so now UTD students can be cadets here on campus, opening up lucrative scholarship and military leadership opportunities for comets on campus. We hosted recruitment sessions for the CIA and FBI and have created a new relationship with our local Federal Executive Board (FEB). The FEB will host a series of events to get our students ready for the federal job market. At the same time, our programs are continuing to strengthen partnerships with local governments, police and fire departments, and regional non-profits.

As always, we welcome alumni back to campus and hope to see you soon. Please enjoy the highlights of the accomplishments of students and faculty.

# 2024 New York City Department of Corrections Curriculum Review Committee

The Commissioner states in his invitation letter to Dr. Burton: "I believe your expertise as a correctional scholar will significantly advance our efforts to identify best practices and evidence-based approaches that can be integrated into our curricula and other training-related materials."

### Tick-Borne Disease Data Guidebook Research Award

Assistant Provost and Associate
Professor of Public Health and Public
Policy, Dr. Sarah Maxwell, was awarded

\$36,300 under the Lyme Disease
Association, Inc. through a competitive application process to create a tick-borne disease county-level data guidebook. This project will develop the most comprehensive tick-borne data resource to date, allowing researchers to access previously unknown and difficult to locate data.

Assistant Professor of Political Science, Dr. Lauren Ratliff Santoro featured her research in an article published in the *American Politics Research*. 
### Dr. Yongwan Chun and PhD GIS Students Collaborate to Research and Publish Two Articles

Professor and Program Head of Geospatial Information Sciences, Dr. Yongwan Chun, in collaboration with his PhD students, showcases research projects in two articles published in *Spatial Statistics*.

"Impacts of Spatial Imputation on Location-Allocation Problem Solutions" is written by Dr. Yongwan Chun, Dongeun Kim, and Daniel Griffith. This article explores how spatial imputation techniques leveraging spatial autocorrelation can improve the estimation of missing values in location modeling weights surfaces, enhancing solutions for spatial optimization problems.






